




## **Inventorying Federal Lands**

Legislation to create a current, accurate real property inventory or "cadastre" of Federal land owned by the Department of the Interior, as well as the U.S. Forest Service, known as the Federal Land Asset Inventory Reform (FLAIR) Act, was enacted into law as part of the Omnibus appropriations bill passed by Congress and signed by President Biden on Thursday, December 29, 2022.

The provision is found in <u>H.R.2617</u> the Consolidated Appropriations Act, <u>FY 2023</u>, also known as the Omnibus appropriations bill (4,155 pages), in Division DD – Public Land Management, Title I Department of the Interior Provisions, Sec. 103, Cadastre of Federal Real Property, beginning on page 2856.

This law will significantly improve federal land management, providing much needed information about the location of federally administered property and its relationship to privately owned and other publicly administered property. There is also value to be gained by state and local governments in understanding that

relationship. There is the potential to create a national inventory of all real property, building on the inventory of Federally administered land, by aggregating existing state and local level cadastral data.

A national cadastre has been a goal for the National Spatial Data Infrastructure (NSDI) for several decades, but that goal has been unattainable. The FLAIR Act provides a critical and missing piece of the puzzle that may help achieve a national land ownership cadastre, through coordination between the public and private sectors.

## **Support funding for FLAIR**

We ask you to support appropriating funds for the FLAIR Act that will enable DOI and USFS to work with State and local agencies and the private sector to explore development of a national cadastre anchored by the Federal land inventory. Such funding should also direct other federal land-holding agencies to work with DOI and USFS, as well as state and local governments, on this effort.
